For more than ten years, I have been working confidently within the classic project management triangle of time, cost, and quality. I manage projects end-to-end, from initiation and implementation through go-live and handover to operations. Currently, I work as an independent project manager on a large-scale M&A integration program in the medical sector, where a corporate group is integrating multiple clinics. I am responsible for several IT infrastructure workstreams in a traditional waterfall setup, operating in a highly regulated environment with intensive stakeholder and people management, and close collaboration with management, business units, and external IT service providers.

My role goes beyond traditional project management: due to my ability to quickly familiarize myself with new topics, I also provide hands-on functional support to teams in the design and implementation of technical and organizational solutions. My responsibilities include defining implementation approaches, managing dependencies between streams, KPI-based reporting, quality and risk management, and ensuring stable handovers into operations.

Previously, I spent several years at Deloitte working in Risk & Compliance for banking and insurance clients, where I supported regulatory transformation programs, including DORA implementation initiatives. This experience enables me to view regulatory, organizational, and technical requirements holistically and translate them into executable project structures.

I hold strong methodological qualifications and relevant certifications, including PRINCE2 Foundation & Practitioner, Scrum, SAFe, IT Risk Management, and ISO 27001 Lead Auditor. This allows me to confidently manage projects in traditional, agile, and hybrid environments while embedding governance and compliance requirements into project delivery.
